



20% DEPOSIT CREDIT BONUS PROGRAM TERMS AND CONDITIONS

A. INTRODUCTION

OTSO Markets and any related entity, including but not limited to OTSO Group (hereinafter referred to as the "**Company**") offers the **20% Deposit Credit Bonus Program** (the "**Program**") to its clients under the terms and conditions set forth herein.

These Terms and Conditions ("**Terms**") form an integral part of the Company's general **Terms & Conditions (the "T&C")**, and their provisions shall be read in conjunction therewith.

By participating in this Program, each Eligible Client acknowledges that they have read, understood, and agreed to be bound by these Terms. Capitalized terms shall have the meaning ascribed to them in the T&C, as amended from time to time, unless otherwise defined herein.

This Program is an **evergreen promotion** and shall remain valid until amended, suspended, or terminated by the Company at its sole discretion.

The Program is designed to enhance trading capacity and shall not be construed as a form of credit, leverage adjustment, or guaranteed return.

B. CONDITIONS OF ELIGIBILITY

Subject to these Terms and the Company's policies, the Program is available to clients who meet the following eligibility requirements ("**Eligible Clients**"):

- a) Hold a verified OTSO Markets Real Account;
- b) Have completed all Know Your Customer ("KYC") and Anti-Money Laundering ("AML") verification procedures;
- c) Deposit a minimum of USD 50 (or equivalent); and
- d) Acknowledge that the Credit Bonus is subject to the trading conditions set out herein.

The following clients are **not eligible** to participate:

- a) Residents of jurisdictions where such promotions are restricted;
- b) Employees of OTSO Markets or its affiliates, or their immediate family members;
- c) Clients with suspended, closed, or inactive accounts;
- d) Participants involved in multiple-account registrations or fraudulent activity.

Special Note:

- This promotion is available **by exclusive invitation only** and is **not open to the general public**.

C. BONUS STRUCTURE

Eligible clients (both new and existing) are entitled to receive a **20% Deposit Credit Bonus** under the following structure:

- Each qualifying deposit shall receive a **20% Credit Bonus**, capped at a total cumulative bonus of **USD 10,000 (or currency equivalent)**
- The Credit Bonus will be automatically credited to the client's account within **twenty-four (24) hours** after the qualifying deposit has been verified by the Company.

Note: All bonus amounts are calculated in USD or equivalent base currency using the end-of-day (EOD) exchange rate.

D. BONUS CREDITING AND USAGE CONDITIONS

1. The Credit Bonus forms part of the client's account equity and may be used to open or maintain trading positions.
 2. The Credit Bonus is **non-withdrawable** and cannot be exchanged for cash or other benefits.
 3. The Credit Bonus cannot be:
 - (i) transferred to any other person;
 - (ii) transferred between accounts held by the same client; or
 - (iii) exchanged for any financial services or benefits provided by OTSO Markets.

E. PROGRAM INTEGRITY AND ABUSE PREVENTION

Any indication or suspicion—at the Company's sole discretion—of **arbitrage, abuse, fraud, manipulation, risk-free profiting, or cash-back arbitrage** connected to the Credit Bonus, or any other form of **deceptive or abusive activity**, shall render all previously credited Credit Bonuses **null and void**.

In such circumstances, the Company reserves the right, at its sole discretion, to:

- a) Remove all Credit Bonuses from the client's account(s);
- b) Cancel all orders and/or annul any profits derived from such activity; and
- c) Suspend or close the client's trading account(s), temporarily or permanently.

The Company shall not be liable for any consequences of Bonus removal, including, but not limited to, forced order closure or Stop-Out resulting from margin changes.

The Company's determination of abuse or fraud shall be final and binding.

F. LIMITATIONS AND DISCLAIMERS

1. The Credit Bonus is provided solely to increase trading flexibility and shall not be treated as actual deposited funds or as a guarantee of profit.
2. The Bonus cannot be used as collateral, nor can it alter the leverage structure of the trading account.
3. Partner commissions, rebates, or other forms of compensation are not payable on transactions executed using Bonus funds.

4. Each Eligible Client may participate in this Program once only; multiple participation through different accounts is prohibited.
 5. The Company reserves the right to refuse or cancel any Bonus application at its sole discretion without providing justification.

1. The Company may amend, suspend, or terminate this Program, in whole or in part, at any time without prior notice.
 2. Any such amendments shall take effect immediately upon publication on the official **OTSO Markets** website.
 3. Continued participation following any modification constitutes acceptance of the revised Terms.

These Terms shall be governed by and construed in accordance with the laws of the jurisdiction in which the Company operates.

Any dispute arising in connection with this Program shall be subject to the **exclusive jurisdiction of the competent courts** of that jurisdiction.
